COMMUNITY NOTIFICATION MEETING REGARDING SEXUALLY VIOLENT PREDATOR

The Lochbuie Police Department will host a public meeting on **Tuesday**, **February 7**, **2017** from **5:30-6:30** pm at the **Lochbuie Town Hall**, to provide relevant information and answer questions about a <u>Sexually Violent Predator</u> moving into the community. Information presented at this meeting will also be made available on the sex offender website available through the Lochbuie Police Department website, following the meeting. Due to the subject matter of the meeting, it is not advisable to bring children. Children under 15 will not be permitted to attend the meeting. It is strongly encouraged that the appropriate information be shared by parents with children after the meeting.

Local Law Enforcement has no legal authority to dictate where a sex offender may live. Unless court restrictions exist, sex offenders are constitutionally free to live wherever they choose. Sex offenders are required by law to notify law enforcement of their residence and law enforcement is authorized to share that information with members of their communities. In the case of sexually violent predators, law enforcement is required to notify members of the community of the offender's address.

The offender's Identity, photo and address will be released at the meeting.
