ADDITIONALLY, some applications will require a petition form with the approval of those affected by the closure. The Town requires that all neighbors affected by the street closure must sign a petition stating that they have been notified of the street closure, hours of closure, and any amplified music, etc. This petition must be submitted to the Clerk's office at the time of submitting the request.
