Temp uses are allowed with approval of a temp use permit for a period determined by staff. The Town of Lochbuie may impose conditions, bonding, and insurance necessary for the health, safety, and welfare of the inhabitants of the community. If occupancy on public property, an agreement by the applicant that such applicant, upon issuance of a Temporary Occupancy permit, will: 1) be required to obtain and provide evidence of current liability insurance in the name of the licensee with the Town of Lochbuie al name as an insured, if applicable; 2) agree to comply with all terms and conditions of the permit; 3) agree to be responsible for all damages to property or injury to persons arising out of exercise of the permit; 4) agree to indemnify and save harmless the Town of all it officers, agents and employees from all suits, action or claims of any type brought for or on account of any injuries or damages received or sustained by any person or property related to exercise of the permit, any act or omission of the permitee, the permitee's agents or employees, or the failure of the permittee to maintain the structure or device or the structure of device or to provide necessary safety devices; and 5) agree to defend against any suit, action, or claim and pay any judgement with costs, which may be obtained against the Town its officers, employees or agents growing out of the injury or damage.
