THE CONTRACTOR/OWNER AGREES TO THE FOLLOWING CONDITIONS:

1. Permit shall be good for thirty (30) working days following the date of validation. The Town reserves the right to void this permit at any time.
2. Contractor assumes all liability for the construction, and render, free from all harm, the Town of Lochbuie.
3. To abide by all Town, State and Federal rules, regulations and codes.
4. To give 24 hours in advance notice before construction begins and call UNCC at 1-800-922-1987 a minimum of 48 hours before digging.
5. The Town of Lochbuie must inspect all phases of work. Trenching that has been backfilled without approval of the Town Inspector shall be reopened at the Contractors expense. No trench longer than 100 lineal feet shall be opened during the day. No trench shall be left open during the night.
6. All site restoration work shall be complete within three (3) business days from permitted work completion and shall be guaranteed for a minimum of one (1) year from final acceptance by the Town, in terms of a Maintenance Bond. Contractor must provide a bond certificate as a condition of this permit prior to commencement of work.
7. To thoroughly compact all backfill by mechanical tamping or other approved means to a minimum of 95 percent density, as determined by the Modified Proctor Method ASTM 1557D; all finished street cuts will match the existing street surface. The top twelve inches (12") of street trenches shall be filled with six inches (6") of road base gravel and six inches (6") of asphalt pavement. Asphalt must be placed in layers, each NOT TO EXCEED THREE INCHES (3") IN THICKNESS. NOTE: Wider saw cut and milling is required for removal of loose trench edges prior to final asphalt patching.
