#### Fellow Citizens of Lochbuie-

It has been a little less than two weeks since I first updated you concerning the town's response to the emergence of the COVID-19 pandemic. I wanted to provide another update on some of the more recent town actions in light of the fact that this pandemic has become an increasingly large concern for those in our small community and across the globe, especially given that I've fielded a variety of questions and addressed a plethora of concerns from citizens in every area of town over the past two weeks.

Effective the morning of Thursday, March 26, 2020, and continuing until Saturday, April 11, 2020, a statewide "stay at home" order will be in effect. This action was taken by Governor Polis to "flatten the curve" of new infections such that health care providers will hopefully be able to handle the influx of new patients and to safeguard the public health. This order applies to all Colorado citizens with a few exceptions allowing all residents to venture out only to acquire essential goods and go to work only if providing certain essential services. Essential activities and services includes government services and public infrastructure construction (like the ongoing projects on County Road 2). Consistent with this public health order, the Town is <u>requiring</u> all Lochbuie citizens to abide by the "stay at home" order to the fullest extent possible. Even absent this order, public health officials have been strongly encouraging everyone that can "stay at home" to "stay at home" for weeks now. We can only "flatten the curve" and blunt the impact of this virus on our healthcare system if we all do our part.

Consistent with the Governor's order and the critical public health concerns, town hall is currently closed to the public, and most town employees are working remotely from their homes, if their position allows for that option. Town business is still being handled promptly and efficiently, and I am in frequent contact with the town administrator concerning the daily, if not hourly, developments concerning COVID-19. To the extent that some "essential staff" will still be at town hall, they work with as much "social distancing" as possible in accord with the advice of public health officials. If you have any urgent questions or concerns, contact town hall via phone or email. And, if all else fails, please send an email to me or any of the board

members and we'll make sure that your concerns are handled as quickly as possible under the circumstances.

I want every Lochbuie citizen to know that police services and public works are fully operational. Our police officers and public works staff are operating in compliance with the public health standards announced by the county, state, and federal governments. They are here. They are working. And they are providing essential services under truly abnormal circumstances. When this public health emergency passes, we will owe all of them a debt of gratitude for their unwavering commitment to this town and its citizenry.

On another note, for the moment, the town parks remain open for exercise and fresh air, such as walks with your family or walking your dogs; however, the town is <u>strongly discouraging</u> the use of the playgrounds. Park equipment is not sanitized between uses and the coronavirus has been shown to live for a significant period of time on surfaces. Moreover, to maintain appropriate "social distancing," groups of friends should not be gathering together at the town parks. The town will continue to monitor the use of the town parks to ensure that public health is not being compromised. If large groups start to gather, the town will reconsider whether total park closures are a necessary step.

Everyone should also know that the town will be temporarily suspending water shut-offs and late fees on water bills for the March 2020 billing cycle (the bills mailed on April 1, 2020). This decision was made to ensure that no citizen is without running water for the duration of this public health emergency.

Lastly, the town is actively considering options to best use our limited resources to assist our sizeable senior citizen community in whatever way possible. If you have ideas, please send them to me or to any other member of the town board. If you are a senior citizen at home and in need of any assistance during this difficult time, please reach out to your neighbors (while still using appropriate "social distancing" to the fullest extent possible). Lochbuie is a community of kind people willing to help. Do not be afraid to ask for help from those closest to you.

Everyone on town staff and on the town board continues to take the emergency of COVID-19 seriously, and our top priority remains the health and safety of every resident in this town.
