



The Mayor's Corner



Fellow Lochbuians-

We're halfway through the year, and the Fourth of July is on the horizon. As we start the downslope toward 2021, here are a few important updates from the Town Board's recent activities:

First, the Lochbuie Police Department recently used their Facebook page to post an important reminder—namely, longstanding town ordinance prohibits the possession, storage, sale, or use of any fireworks within town limits. I wanted to share that reminder here, because it is especially important to be cognizant of that law in a dry year where the risk of unintended fires is high.

Second, the Town Board will be resuming in-person board meetings on July 7, 2020. Those meetings occur in a "hybrid" fashion, meaning any board members or members of the public that feel more comfortable attending virtually will be given that option.

Third, as I mentioned in a previous newsletter, the Town Board is considering the adoption of an ordinance to place certain requirements on the development of any future gas stations or truck stops within town limits. If you have questions, comments, or concerns related to that ordinance, please feel free to reach out to town hall or to attend the board meeting on Tuesday, July 7 at 6:30pm. As noted above, there will be both in-person and virtual options to attend that meeting.

Fourth, the construction of the new round-a-bout at the intersection of County Road 2 and the frontage road remains on schedule for completion around Labor Day 2020. The construction crew recently shifted to Phase 2 of that project, which includes a three-way stop at the intersection. Please be cognizant of your speed and the stop signs when you approach that work zone.

Fifth, the Town's portion of the County Road 2 widening project is essentially complete. The road is done, the sidewalk was recently completed, and the streetlights are in the process of being installed. All that remains is a few repairs to the areas surrounding the project. The Town is now actively working with the relevant developers to schedule the remaining portion of the widening project from Homestead Avenue to 50th Street in Brighton.

Finally, the Town Board is aware that a number of citizens expressed concerns about the Spring Clean-up Event. The Board will discuss the future of that event, including potential changes or improvements, at an upcoming meeting.

Please continue to stay happy, healthy, and safe as we continue to live under our "new normal." And, as always, do not hesitate to contact me or any of the members of the Town Board with your questions, comments, or concerns.

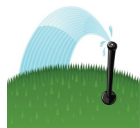

JUST A REMINDER

It is illegal to shoot fireworks anywhere in the Town of Lochbuie. The Fire Department is urging all residents to please enjoy fireworks at one of the surrounding town/city displays ONLY! Per the Town Municipal Code (Article XII, section 10-12-2), anyone **possessing, storing or exploding** any fireworks within Town limits will be subject to fines and penalties.

"Except as provided herein, it is unlawful for any person to possess, store, to offer for sale, expose for sale, sell at retail or use or explode any fireworks within the Town limits. Any person convicted of violating this Section shall be subject to the penalties set forth in Subsection (Chapter 10, Article 1, section 10-1-70(d))."
